<b>Objectives</b>	⇒	To enable selected applicants to undertake initial Master's studies at conservatories or art schools affiliated with universities of applied sciences.

<b>Validity</b>	⇒	The Scholarship is only valid to pursue the initial master's degree. The arts scholarships are granted at one of the above-mentioned universities of applied sciences in Switzerland. It is not valid for mixed programmes (part time in Switzerland and part time in another country).
<b>Target group</b>	⇒	Highly qualified young artists - from all artistic fields - wishing to pursue an initial master's degree. These scholarships are only offered to citizens of countries with which Switzerland has reciprocity agreements for art scholarships.
<b>Duration</b>	⇒	12 months (starting in September), prolongable up to 21 months at most depending on the Master programme chosen and the necessary ECTS credits.
<b>Amount and additional allowances</b>	⇒	The scholarship amounts to a monthly payment of CHF 1,920. ⇒ For non-EU and non-EFTA grantees only: the FCS pays mandatory Swiss health insurance. ⇒ There are no family allowances. ⇒ Scholarship holders from non-EU and non-EFTA countries receive a flight allowance (lump sum) for a ticket back to their country of origin (provided at the end of the scholarship). ⇒ Special CHF 300 housing allowance (paid once at the beginning of the scholarship).

<p><b>Eligibility criteria and specific conditions</b></p>	<ul style="list-style-type: none"> <li>⇒ Bachelor's degree or equivalent.</li> <li>⇒ Applicants must be born after <b>31 December 1985</b>.</li> <li>⇒ Applicants should start their scholarship no later than three years after graduating with their Bachelor's degree.</li> <li>⇒ Applicants who have been in Switzerland since more than one year at the beginning of the scholarship in September are not eligible. 4a) High-quality CD of three different styles of music if the music involves interpreters and directors. Composers have to submit their scores (CD labelled with name, surname and country).

**For painters, graphic artists and sculptors:**

4b) Copies or photos of three pieces of your work, along with rough drafts (incl. their dates of creation; work labelled with your name, surname and country).

5) A proof for “admission is under consideration” at the intended Swiss arts or music school (conservatory). This may be in the form of a conditional acceptance pending an entry exam or other specific requirements.

⇒ If applicable, a copy of the letter from a professor confirming the supervision of the studies.

6) Two confidential letters of recommendation from two different professors in the applicant’s field (use only the FCS reference form – originals in sealed envelopes only for the 1<sup>st</sup> set). No copies for 2<sup>nd</sup> set.

7) Photocopies of certificates and grade sheets from previously attended universities/colleges and diplomas with grades, starting with the most recent. If not in English, French, Italian or German with attested certified translations in English. Do not submit the original certificates.

8) **Signed** medical certificate (use only the FCS health certificate form).

9) Two copies of the applicant’s passport (main page with personal data). Dual nationals add copies of both passports. Applicants already in Switzerland during the application procedure add a copy of the residence permit for Switzerland.

<b>Offered by</b>	⇒	The Swiss Government via the Federal Commission for Scholarships for Foreign Students FCS
<b>Objectives</b>	⇒	To enable selected applicants to undertake a PhD at one of the 10 Swiss cantonal universities, the two Swiss federal institutes of technology or the Graduate Institute.

<b>Validity</b>	⇒	The scholarship is valid only for full-time PhD studies in Switzerland. It is not valid for mixed PhD programmes (part time in Switzerland and part time in another country). ⇒ “Cotutelle de these”: PhD students with an ongoing or planned doctoral project that is carried out within the framework of a formalized agreement between two universities (“cotutelle de thèse” cooperation between a Swiss and a foreign university) and under the joint direction of two supervisors are eligible for a 12 month research fellowship only.
<b>Target group</b>	⇒	Highly qualified postgraduate students (possessing the required degrees) from all academic fields.
<b>Duration</b>	⇒	12 months (starting in September) prolongable up to 36 months based on the achieved academic results.

## Amount and additional allowances

- ⇒ The scholarship amounts to a monthly payment of CHF 1'920.
- ⇒ For non-EU and non-EFTA grantees only: the FCS pays mandatory Swiss health insurance.
- ⇒ There are no family allowances.
- ⇒ No financial support for fieldwork or for conferences.
- ⇒ Scholarship holders from non-EU and non-EFTA countries receive a flight allowance (lump sum) for a ticket back to their country of origin (provided at the end of the scholarship).
- ⇒ Special CHF 300 housing allowance (paid once at the beginning of the scholarship).
- ⇒ One-year half-fare public transportation card.
- ⇒ Support services and various trips, dinners and sightseeing tours organised for Swiss Government Excellence Scholarship holders.

## Eligibility criteria and specific conditions

- ⇒ Master's degree or equivalent university degree achieved **before 31 July 2021** (degree certificate) recognised by the Swiss university. As a proof, the degree has to be submitted to the Federal Commission for Scholarships before the start of the scholarship.
- ⇒ Applicant's date of birth after **31 December 1985**.
- ⇒ Applicants must provide a letter from an academic host professor (including her/his short CV) at the chosen Swiss university confirming why she/he is willing to supervise and support the PhD thesis. Without such specific support letter, the application will be rejected.
- ⇒ If an assistant professor supports a candidature, a full professor who is entitled to supervise the PhD during the entire scholarship has to co-sign the support letter.
- ⇒ Applicants must have a research proposal including a timeframe. This is the centrepiece of the application. The applicant must devote all required attention to it.
- ⇒ Applicants must be in command of the necessary language skills required for the PhD studies/ research.
- ⇒ Applicants who have been in Switzerland since more than one year at the beginning of the scholarship in September are not eligible. Reference document if applicable: residence permit to be added to the application documents.
- ⇒ Applicants who have already benefited from a Swiss Government Excellence Scholarship are not eligible to apply for a second scholarship. Scholarship holders are expected to move to Switzerland during their grant period.
- ⇒ **PLEASE NOTE:**
- ⇒ The FCS application for a PhD scholarship and the application for admission by a Swiss University for a PhD study are two separate procedures.
- ⇒ The admission to a PhD study at your chosen Swiss University is a *conditio sine qua non* for a potential attribution of a FCS scholarship - but no guarantee though for a positive decision by the Federal Commission for Scholarships for Foreign Students FCS. It is the applicant's responsibility to manage both procedures in parallel.



- ⇒ There are two different ways to achieve a doctorate degree (aka PhD). The first way consists in undertaking **doctoral studies under the supervision of an academic mentor** (supervisor). In this case, the **admission to the PhD takes place after the scholarship start**.
- ⇒ The second way consists in **being admitted to a doctoral school**, which provides the framework for the following doctoral studies. Please inquire your admission directly at the corresponding school.
- ⇒ In addition to all other application documents (including the support letter from a supervisor), the **admission letter from the doctoral school is required with the application dossier**. As this takes, time applicants must plan accordingly and submit their application for admission to the doctoral school sufficiently in advance of the scholarship programme deadline.
- ⇒ If the chosen doctoral school does not allow you to contact a supervisor before being admitted to the school, the application for the Swiss Government Excellence Scholarship is not possible.



	<p>⇒ PhD students with an ongoing or planned doctoral project that is carried out within the framework of a formalised agreement between two universities (“cotutelle de thèse” cooperation between a Swiss and a foreign university) and under the joint direction of two supervisors <b>are eligible for a 12 month research fellowship only.</b></p>
<b>Target group</b>	<p>⇒ Highly qualified postgraduate researchers from all academic fields as well as young medical doctors.</p>

<b>Eligibility criteria and specific conditions</b>	<p>⇒ Master's degree or equivalent university degree achieved <b>before 31 July 2021</b> (degree certificate) recognised by the Swiss university. As a proof, the degree has to be submitted to the Federal Commission for Scholarships before the start of the scholarship.</p> <p>⇒ Applicants must be born after <b>31 December 1985</b>.</p> <p>⇒ Applicants who have been in Switzerland since more than one year at the beginning of the scholarship in September are not eligible. Reference document if applicable: residence permit to be added to the application documents.</p> <p>⇒ Applicants must provide a letter from an academic host professor (including her/his short CV) at the chosen Swiss university confirming why she/he is willing to supervise and support the research. Without such specific support letter, the application will be rejected.</p> <p>⇒ Applicants must have a research proposal including a timeframe. This is the centrepiece of the application. The applicant must devote all required attention to it.</p> <p>⇒ Applicants must be in command of the necessary language skills required for the research/studies.</p> <p>⇒ Applicants who have already benefited from a Swiss Government Excellence Scholarship are not eligible to apply for a second scholarship.</p> <p>⇒ Scholarship holders are expected to move to Switzerland during their grant period.</p>

<b>Selection criteria</b>	<p>⇒ The following aspects and selection criteria are primarily considered:</p> <p>⇒ The candidate: academic profile, research capacity and motivation.</p> <p>⇒ The research project: originality and methodological soundness.</p> <p>⇒ The academic context: quality and context of supervision and potential for future academic cooperation.</p>
<b>Application timeframe</b>	<p>⇒ Opening of the call: 02 September 2020</p> <p>⇒ Application deadline: 01 December 2020</p> <p>⇒ Beginning of the scholarship: <b>01 September 2021</b></p>

Dual nationals add copies of both passports.
